<p><b>Study Abroad (Subject pathway) Programmes</b></p>	<p><b>Study Abroad (Subject pathway)</b>  This programme is designed for our exchange partnerships, where the agreement between our two institutions covers one or more designated subject areas. Your students will be nominated under the Study Abroad (Subject pathway) programme and assigned to the academic area in which we have agreed to exchange students. They will take the majority of their units within this subject, with the option to take a small number of credits in other academic areas of interest, or from our Centre for Academic Language and Development. If your students are direct-enrol (fee-paying), they can choose to apply for this programme if they wish to focus their studies at Bristol in one core subject area.</p> <p><b>Study Abroad with English Language: STABEL (Subject pathway)</b>  For students who don't currently meet the English language requirements for the Study Abroad (Subject pathway) programme, STABEL combines Study Abroad with a pre-sessional English language course starting in June or July. This intensive English language course will prepare them for study in Bristol and lasts for six or ten weeks, depending on their current English language level. If they successfully complete the pre-sessional course, they will progress onto the Study Abroad (Subject pathway) programme in September. The teaching is the same for both options but the on-campus option gives students the chance to familiarise themselves with life on campus and get an introduction to living in the UK before regular teaching begins in September.</p>

We will follow up with information to the students (with the email from which they were nominated in cc) about how to apply.</p> <p>When nominating a student, please make sure they are suitable for the programme, based on our entry requirements and that they have all the required documents ready to be submitted before our application deadline. This will help us and your students have a smooth application process.</p>

<p><b>Academic requirements</b></p>	<p><b>3.0 GPA (based on US 4.0 system) or equivalent</b> Students must have completed at least one year of study at university level at the time of their application which should be evidenced on their transcript. For 4-year degrees, we recommend at least 2 years of study. We have grade conversion in place for all partners who don't grade on the 4.0 GPA system. <p><b>English language requirements</b></p>	<p><b>IELTS 6.5 with minimum 5.5 in all skills</b></p> <p>All inbound students, including year-long and single-semester students, are required to provide evidence that they meet our English Language requirements as part of their application. A full list of accepted English language certificates for the 2024-25 academic year can be found on our Study Abroad <a href="#">Language Profile</a>.</p> <p><b>Please note the length of validity of each accepted certificate as noted on the profile.</b></p> <p>If your institution fully teaches and assesses in English and can evidence that your English language entry requirements are equivalent to those required to come to Bristol, we may be able to put a Medium of Instruction letter in place for your students which would exempt them from the English language requirements. Please contact the Inbound team on <a href="mailto:cfsa-inbound@bristol.ac.uk">cfsa-inbound@bristol.ac.uk</a> for further information about this prior to nominating the students.</p> <p>Students who fall below our English language requirements may wish to consider the STABEL (Study Abroad with English language) programme. The English Language requirements for STABEL vary depending on the length of the pre-session course. We can <b>only</b> accept IELTS Academic for UKVI from authorised test centres for entry to the STABEL programme as follows:</p> <ul style="list-style-type: none"> <li>• STABEL with 6-week pre-session course: IELTS Academic for UKVI 6.0 overall with 5.5 in all skills</li> <li>• STABEL with 10-week pre-session course: IELTS Academic for UKVI 5.5 overall with 5.0 in all skills</li> </ul> <p>Please note that the STABEL programme has additional tuition fees for the pre-session course.</p>
<p><b>Duration of study</b></p>	<p>We accept Study Abroad students both for semester-long and year-long exchanges. Please note that due to the change on the structure of the academic year, we anticipate being able to offer more semester-long units in subjects where we previously offered mostly year-long units. Study Guides will be published on the Centre for Study Abroad (Inbound) website with a list of available units in April 2024.</p>
<p><b>Restrictions for Study Abroad students</b></p>	<p><b>Departments not open to Study Abroad students</b></p> <p>Schools of Medicine, Dentistry and Veterinary Science.</p> <p>Most postgraduate level units, except for selected ones from our Faculty of Engineering and Faculty of Science which form part of a 4-year integrated Masters programme. Masters students should only be nominated if they can take undergraduate units as part of their placement at Bristol and Undergraduate students are only permitted to take Masters level units where they have significant, relevant academic experience.</p>

	<p><i>The restrictions below are accurate as of November 2023 but further updates and any changes will be highlighted on our website.</i></p> <p><b>Engineering</b> Please note that Computer Science units are only available at third and fourth year level and therefore are only suitable for students who have already completed 2 or 3 years of a Computer Science degree. Due to the change of the structure of the academic year, we anticipate being able to offer more semester-long units within Engineering, which previously offered mostly year-long units. We strongly advise that students review our Study and Subject guides before submitting their application.</p> <p><b>Psychological Science</b> Psychology is taught as an experimental science rather than a social science at Bristol. Students taking Psychology units are generally required to have a strong background in Chemistry, Biology and Neuroscience. Please note that the School of Psychological Science recommends that students only undertake one 3rd year unit per semester. If students are able to come to Bristol for the full academic year this would give them a wider range of unit choices as the school does not offer a large number of 2nd or 3rd year units in each semester.</p> <p><b>General guidance</b> Study Guides will be published on the Centre for Study Abroad (Inbound) website with a list of available units in April 2024. Please note that unit choices cannot be guaranteed in advance and that unit registration for Study Abroad students will be finalised when they arrive in Bristol. Please also see below the guidance about unit levels and suitability for students.</p>
<p><b>Unit levels and credits</b></p>	<p>Undergraduate degrees in the UK are three-year programmes. Inbound Study Abroad students can choose units from all three years. For subjects that students haven't studied at their home institution, we recommend first-year units. Second-year units are most common for students taking their major/minor abroad, and third-year units are suitable for students in their major subject if they are close to graduation. Second and third year units may be subject to pre-requisite checks with the academic department at the start of the semester.</p> <p>A full credit load at Bristol is 60 credits (30 ECTS) per semester or 120 credits (60 ECTS) for a full academic year. Students cannot exceed this credit load and must take a minimum of 50 Bristol credits per semester (100 per year) to be considered a full-time student and to meet the conditions of their visa. Student must engage with classes and assessments for all units regardless of which units they plan to transfer for credit at their home university.</p>

<p><b>Supporting documents required to be submitted with application</b></p>	<ul style="list-style-type: none"> <li>• Online application form (signed by the student)</li> <li>• Official academic transcript (electronic copy/scanned copy) in English</li> <li>• Evidence of English language proficiency</li> <li>• A clear, colour copy of passport personal information page</li> <li>• A Learning Agreement indicating their unit choices</li> </ul> <p>Students from Europe who are utilising Erasmus+ funding are welcome to submit an Erasmus+ Learning Agreement template from their home university. All other students can download a University of Bristol Learning Agreement template from our website.</p> <p>The application pages of our website are updated in February each year after we have welcomed our January entry students. Please advise students that submitting the online application alone is not considered a complete application. <b>All supporting documents must be submitted via email by the application deadline. Please note that we cannot guarantee to accept applications from students after the deadline, including applications which have been partially submitted or are missing some supporting documents.</b></p>
<p><b>Visa Information</b></p>	<p>Non-UK/Irish passport holders coming for more than 6 months must apply for a Student visa. Students coming for less than 6 months must obtain a Standard Visitor visa. Some nationalities can obtain a Standard Visitor visa at the border and others must apply in advance. As of October 2023, Qatari nationals, who wish to travel to the UK on or after 15 November 2023 and from 1 February 2024 Bahrain, Jordan, Kuwait, Oman, United Arab Emirates and Saudi Arabia nationals who wish to travel to the UK on or after 22 February 2024 will be able to apply for an Electronic Travel Authorisation (ETA).</p> <p>More information is available on our <a href="#">website</a> and guidance is sent to students after they have accepted their offer. <b>Please ensure that students have a valid passport at the point of application or are due to receive one very soon if they have applied for a new/renewed passport.</b></p>

<p><b>Accommodation</b></p>	<p><b>September entry</b> Exchange students from institutions outside of Europe and all non-exchange students are guaranteed an offer of a place in University accommodation, if they apply by the deadline. Exchange students from institutions within Europe are not guaranteed an offer but are still welcome to apply and are given support to find private accommodation.</p> <p><b>January entry</b> Non-exchange students are guaranteed an offer of a place in University accommodation, if they apply by the deadline. We cannot offer an accommodation guarantee to exchange students, but we make every effort to place as many students as possible in a University residence or help them find private accommodation. Accommodation costs vary. More information can be found on our <a href="#">website</a>.</p> <p><b>Please note:</b> If students are successful in their application for University accommodation, they are typically given a 48-hour window to accept their offer and must do so within this timeframe to secure their accommodation. If they do not accept their offer by the deadline, the offer of accommodation will be withdrawn and they are unlikely to be able to reapply.</p>
<p><b>Health and Insurance</b></p>	<p>Students studying with us for less than six months on a Standard visitor visa will not be covered by the National Health Service (NHS) and should therefore make sure that they obtain adequate medical insurance that covers them while they are abroad. Students studying with us for a full academic year travelling on a Student visa, and those with a valid UK/Irish passport, will be covered by the National Health Service and therefore do not require medical insurance but will still need to take out travel insurance for flights etc. and contents insurance for their belongings. Student visa holders pay the NHS surcharge as part of their visa application. <p><b>Disability</b></p>	<p><a href="#">Disability support</a> is available to all Study Abroad students who study at the University of Bristol. We support students with a range of disabilities, learning difficulties, and other health and mental health conditions. We strongly encourage students to declare if they have a disability when they fill out their application so that we can prepare to support them. The adjustments that students receive at their home university are not automatically put in place at Bristol, so it is important they declare their disability and inform us of any requirements. Our team has a disability coordinator that works with Study Abroad student, and our Disability Services team, to ensure <a href="#">study and assessment adjustments</a> are put in place.</p>
